

Charity Challenge Event - Terms and Conditions for Own Place Participants

Thank you for fundraising in aid of the Royal Brompton and Harefield Hospitals Charity (*Registered Charity No. 1053584*).

These Terms & Conditions apply to all voluntary fundraising activities and by completing our Own Place website form you are agreeing to comply with them. We suggest that you keep a copy of these terms and conditions for your records.

Fundraising:

- You agree to act lawfully when fundraising in aid of The Royal Brompton and Harefield Hospitals Charity and comply with any instructions or guidance provided in relation to your fundraising activities.
- If you are organising additional events or fundraising activities to support your fundraising efforts, then you agree that it is your responsibility to organise all aspects of any fundraising activity undertaken by you. You will also be responsible for any costs, taxes, insurances or expenses incurred or arising in connection with your fundraising activities.
- You agree to pay over to The Royal Brompton and Harefield Hospitals Charity all sponsorship money within 6 weeks after your event date.
- Any sponsorship raised in donations is non-refundable.
- When producing any materials using The Royal Brompton and Harefield Hospitals Charity logo, you must first seek approval from The Royal Brompton and Harefield Hospitals Charity Events Team.

Your Event Participation:

- By completing the Own Place form, you are confirming that you have secured your own place in the challenge event specified in your registration form through the event organisers. The Royal Brompton and Harefield Hospitals Charity holds no responsibility in securing or confirming your place in this event.

- It is your responsibility to check that you are above the minimum age to participate in the event, as specified by the event organiser, and to organise parental consent if required.
- You agree that you are entering the event of your own volition and therefore confirm that your general state of health and fitness is good and that you understand that any injury or loss sustained by you during the race/training is your own responsibility and not the responsibility of The Royal Brompton and Harefield Hospitals Charity.
- If you have a medical condition or are unsure of your physical ability to take part in the event, you must seek medical advice from a general practitioner prior to your participating in the event.
- You understand that it is your responsibility to read any terms and conditions issued by the event organisers and to comply with these.

Consent and photos:

- By providing your personal information when you sign up to fundraise for The Royal Brompton and Harefield Hospitals Charity, you understand that The Royal Brompton and Harefield Hospitals Charity will contact you via phone or email in order to communicate relevant event information before and after your event.
- By taking part, all participants confirm that they are happy for any footage or photographs taken during their participation in the event to be used to publicise The Royal Brompton and Harefield Hospitals Charity generally, including but not limited to: website, emails, social media and video broadcasts.
